EEA Budget Committee Update

The **EEA Budget Committee** held four working sessions on **May 20, May 22, May 29, and June 3**, totaling over **6 hours** of collaborative review. During these meetings, committee members carefully examined **over a decade of EEA financial records** to understand historical spending patterns and make informed decisions for the future.

As a result, the committee has developed a **2025–2026 proposed budget** designed to **return more value directly to members** through thoughtful and transparent financial planning.

*Note: A full comparison to the **2024–2025 budget** is not yet available because the fiscal year is still in progress. However, this comparison will be ready prior to the **August Convocation Day General Membership Vote**.

- The updated EEA Constitution & Bylaws.

Understanding Dues Audits & Budget Meetings

As members of the Elyria Education Association (EEA), it's important to understand how our union ensures accountability and transparency through two key financial processes: the Dues Audit and the Budget Meeting.

What is a Dues Audit?

A dues audit ensures that your union dues are accurately collected, categorized, and reported. It confirms that funds are correctly transmitted to the appropriate organizations like the OEA, NEOEA, and NEA.

- Ensures your dues are accurate and fair
- Protects your voting rights and benefit access
- Confirms legal and financial compliance
- Promotes financial transparency and trust

S What is a Budget Meeting?

A budget meeting determines how EEA allocates funds for the year. It reviews past spending, plans for upcoming needs (like negotiations and events), and helps set local dues.

• Why It Matters to You:

- See how your dues are spent
- Voice your priorities for union spending
- Ensure financial stability for negotiations and support

- Rep. Assemblies, Miscellaneous, Social: reclassified or removed

These updates reflect the EEA's evolving priorities: clearer budgeting, stronger support for member development, and readiness for negotiations and representation.

- 5. Some previously bundled expenses now listed individually
